Frequently Asked Questions - DLI for Smartboards

<p>Q. What is the purpose of the CD? Does this CD replace the DLI book?</p> <p>A. The CD does not replace the book. It is designed to be used in concert with your DLI print edition, and it includes <u>only</u> the items you would display for class discussion. (Day One-Day Four student tasks).</p> <p>Q. Why do I need the DLI book?</p> <p>1-The book provides all of the blackline masters for duplication of the student materials: pre-post assessments, Day One-Four student tasks, Day Five assessments, and spelling. (Many of these pages are not on the CD.)</p> <p>2-The book provides the teacher resource sections that are the engine for the DLI program. They include introductory materials to support implementation, mini-lessons to support introduction of each skill, and the KEY. (This section is two-thirds of the book.)</p> <p>Reproduction Privileges for the Teacher's Edition: <u>Limited Reproduction Rights:</u> <i>With the purchase of one book, a teacher may reproduce student materials from the DLI section and spelling lists for his/her individual classroom, but not for any other classroom.</i></p> <p>Not Reproducible: The introductory section, mini-lesson section, and the KEY are teacher resources and are not reproducible.</p>	<p>Q How many CDs do we need to purchase for our team?</p> <p>A Every teacher needs a CD. This is a single use media product and as such may be used on a single computer used by one person at a time.</p> <p>Q. What are the copyright terms for this CD?</p> <p>A. Copyright law for this kind of media does NOT permit copies of any type, net-working, or transmission. In plain language, this includes copies of the CD, paper copies of the documents on the CD, uploading files to teacher/school/personal website, or transmission of the files via the Internet.</p> <p><i>*EXCEPTION: Day One-Day Four tasks may be posted digitally for online access by your students in a platform such as Google Classroom, but ONLY if access is fully secured. This access must be limited to the teacher's own students and not be accessible to other teachers and/or students.</i></p> <p>Q. What forms of technology support the use of these CDs?</p> <p>A. The PDF files on the CD work well with interactive whiteboards: SMARTboards, Promethean boards, and their competitors and LCD projectors.</p> <p>B. Teachers using document cameras will not need this CD.</p>
<p>Q. May I print paper copies from the CD?</p> <p>A. The copyright does not permit copies from the CD.</p> <p>Q. Is this software interactive?</p> <p>A. No. Unfortunately, the cost of developing interactive features would make the CD cost-prohibitive.</p>	<p>Q I have an earlier edition of the book. Will this CD correlate with it?</p> <p>A. No. Each CD correlates with its respective print edition.</p>
